Corporate Resolution
Regarding
Financial Arrangements of Corporate Subunits

WHEREAS, the Girl Scouts of the Northwestern Great Lakes ("Council") Board of Directors is the corporate head of the entire organization, and
WHEREAS, subunits of the Council may desire to keep finances in a designated institution, and
WHEREAS, the Board of Directors and the management staff maintain a fiduciary responsibility regarding all monies held for Girl Scout purposes, and
WHEREAS, the Corporate Board or management may have reason to require access to subunit accounts in order to fulfill that fiduciary responsibility or to administer Council policies.
NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Corporate Board of Directors authorize the troop and service unit subunits to open accounts and hold monies in a designated institution in accordance with Council policy.
2. The current Corporate Chair/President, Treasurer, CEO, or Comptroller/CFO will maintain signatorial privilege regarding access to those accounts in the event of Council policy non-compliance or inactivity.
3. Each account must bear the name "Girl Scouts of the Northwestern Great Lakes, Troop # \_\_\_\_\_ OR "Girl Scouts of the Northwestern Great Lakes, \_\_\_\_\_ Service Unit", must be opened under Federal ID # 39-1016314, and must comply with all Council financial policies.

BE IT FURTHER RESOLVED, that in addition to those opening subunit accounts, the following individuals will also be authorized to request account information, to sign any checks, drafts and orders, including orders or directions in informal or letter form, against any subunit funds at any time standing to the credit of Girl Scouting with the institution and the institution is authorized to honor any and all checks, drafts and orders to be signed - without the consent of the current signers on the accounts, and Council may close the accounts at any time and transfer the account funds to Council, without the consent of the Agent or the current signers on the Accounts:

- 1. Council Board President 3. CEO
2. Council Board Treasurer 4. Comptroller/CFO

BE IT FURTHER RESOLVED, that each of the foregoing resolutions shall supersede all other resolutions and shall continue in force until express written notice of its revision or modification has been received by the institution, but if the authority contained in them should be revoked or terminated by operation of such law without such notice, it is resolved and hereby agreed that the institution shall be held harmless by the Corporation in so acting after such revocation or termination without such notice.
